

There are several circumstances for which Evergreen Montessori requires the consent of parents or legal guardians. These separate items for which we are requesting authorization or consent are listed below. Please mark each item clearly so that we understand your family needs.

ITEM 1: Photo / Media Authorization / Research, Experimental Procedure / Public Relations

I hereby grant or deny permission to Evergreen Montessori to use the image of my child, as marked by my selection below. Such use includes the display, distribution, publication, transmission, or otherwise use of photographs, images, and/or video taken of my child for use in materials that include, but may not be limited to, printed materials such as brochures and newsletters, videos, and digital images such as those on the Evergreen Montessori Web site.

☐ Yes, I give unrestricted permission for my child's image to be used in print, video, and digital media. I agree that these images may be used by Evergreen Montessori for a variety of purposes, and that these images may be used without further notifying me. I do understand that the child's name will not be used in conjunction with any images.

ITEM 2: Art Display

☐ Yes, I give unrestricted permission for my child's work/art to be displayed. I understand that my child's work may be identifiable to others.

ITEM 3: Parent Handbook

☐ An electronic copy of the Evergreen Montessori Parent Handbook was emailed upon enrollment. I have read and I understand its contents. I understand that it is my responsibility to be familiar and comply with the policies and procedures stated in the handbook.

ITEM 4: Sunscreen

During the summer, parents should apply sunscreen to their child(ren) before bringing them to school. Staff will re-apply sunscreen to students prior to going outside in the late morning, with parent permission.

☐ Yes, I give permission to Evergreen staff to apply Coppertone Water Babies SPF 50 sunscreen on my child.

☐ I prefer to provide my own sunscreen. I agree to bring a new bottle of sunscreen for my child, labeled with my child's first and last name. I give permission for Evergreen staff to apply the provided sunscreen.

☐ I prefer sunscreen not be applied on my child. I understand that if my child receives a sunburn, I will not hold Evergreen Montessori or its staff responsible.

ITEM 5: Hand sanitizer

☐ Yes, I give permission for my child to use hand sanitizer. I understand that typically this would only be used in between regularly scheduled handwashing and does not replace regularly scheduled handwashing.

ITEM 6: Jewelry/drawstring Policy

For children, there is great risk associated with strangulation due to jewelry worn around a child's neck and clothing with drawstrings. To prevent injuries, the children will not be permitted to wear jewelry (necklaces) or other items worn around the neck. This rule also applies to scarves and mittens or gloves attached with a string through the sleeve of a jacket. Please check your child's clothing and remove all drawstrings from clothing worn to school.

Exceptions to the policy will be jewelry worn for medical alert or religious affiliation. Please see the director if you'd like to authorize one of these exceptions.
